In case of any default in payment as herein in agreed, the entire note shall become immediately due and payable at the option of the holder. Each party to this note whether as Maker, Co-Maker, Endorser of Guarantor, severally waived presentment of payment, demand, protest and notice of protest dishonor of the same.

It is further agreed by the party hereof that in case non-payment shall be made at maturity, he shall pay the cost of collection and attorney's fees and the amount equal to TWENTY PERCENT (20%) at the principal and interest due on the note, but such charges shall in no case be less than TEN PESOS (P10.00).

In case of judicial execution of this obligation or any part of it, the debtor waive all his/her right under the provision of Rule 3, Sec. 13 and Rule 39, Sec. 12 of the Rules of Court.
